**Contact Cobb County School Board Member David Banks and ask him to offer an apology to the citizens of Cobb County for forwarding emails that chained debunked statistics about immigrants**

On November 23, 2016, Cobb County School Board Member David Banks forwarded chain emails that contained debunked statistics about immigrants from his personal email account to a wide distribution list.

Although Mr. Banks' did not use his Cobb County School Board email address to forward the emails, it still raises concerns – especially in his role on the school board where he should be serving the interest of all Cobb County students.

To date, Mr. Banks has refused to speak with community groups and/or offer an apology. ## **Call, Email, Fax Congressional Representatives**

Contact your Congressional Representative and U.S. Senators Isakson and Perdue and ask them to oppose the confirmation of Betsy DeVos for Secretary of Education. DeVos has no professional experience in public schools, but she has lobbied for decades to expand charter schools and taxpayer-funded vouchers for private and religious schools. Additionally, DeVos is retaining her position as co-trustee of three family trusts, at least one of which has an indirect financial stake in Sextant Education, which operates a chain of for-profit colleges, through its parent company AEA Investors. **The vote will occur at 10 a.m. on January 31, 2017.**
