

# RAFFLE RULES AND FAQ

## 2020 “Gimme 5 for 5” RAFFLE Terms and Conditions

### RULES AND INFORMATION

#### DESCRIPTION:

**Marietta-Roswell Alumna Chapter (MRAC) of Delta Sigma Theta Sorority, Inc is sponsoring an electronic raffle from September 12, 2020 through November 21, 2020 and will grant one winner \$5,000. Other prizes are 1<sup>st</sup> Prize - \$1000 and 2<sup>nd</sup> Prize - \$500. All prize recipients are randomly selected.**

#### ELIGIBILITY:

You must be 18 years old or older to purchase an electronic raffle ticket (\$5 each). Tickets can only be purchased for the campaign via Rallyup.com. Only (1) individual may be identified as the purchaser (or buyer/owner) of a raffle ticket. **Core members (Chair, Co-Chair of Fundraising and members administering raffle) of MRAC Raffle Sub-Committee and members of the Marietta-Roswell Alumna Chair Executive Committee are ineligible to win. A ticket purchased by an ineligible person is void and cannot be a winning ticket.** All federal, state, and local laws and regulations apply. All tickets will be purchased using electronic ticketing system, RallyUp. There will be no paper tickets. The ticket purchaser acknowledges that they are aware of and agrees with these raffle official rules.

#### PAYMENT:

All ticket purchases will take place electronically via Rallyup.com, a secure platform used for electronic raffles. Only debit or credit cards can be used to purchase tickets. There will be a minimal processing fee per transaction. There is no limit to the number of tickets purchased. When purchasing tickets, your full name, phone number and email address are required fields that must be completed to purchase tickets. Once your purchase is complete, you will receive an email confirmation of payment and your specific raffle ticket numbers.

Should you choose the option for “donation” only, that transaction is final and will not transfer to a raffle ticket purchase. MRAC members will not collect any information or any funds for ticket sales. Also, please note raffle tickets and donations made are not transferable.

MRAC and agents alike (i.e. board members, vendors, volunteers, and members) assume no liability for lost or undelivered tickets. **Active Members of Marietta-Roswell Alumnae Chapter Executive Committee and MRAC Raffle Sub Committee members are not eligible to win.**

#### DRAWING AND PRIZE:

Once all ticket purchases are confirmed, the ticket numbers are automatically generated and emailed to the purchaser. Ticket sales will continue until 30 minutes prior to the drawing on Saturday, November 21, 2020. At that time, the ability to purchase tickets online will be disabled. MRAC reserves the right not to accept entries at their discretion.

Grand prize value is \$5,000. Other prizes are valued at \$1000 and \$500 will be available to win. Odds of winning the prizes depends on the number of raffle tickets sold during the Raffle period. If tickets sold do not reach \$7500 before raffle drawing, MRAC reserves the right to convert Grand Prize to a 50/50 based on funds received. Other raffle prizes will be given away as advertised.

**RETURN AND CANCELLATION:**

All purchases of raffle tickets are final and non-refundable.

MRAC reserves the right to cancel, suspend and/or modify the Raffle, or any part of it, if any fraud, or other factor beyond MRAC's reasonable control impairs the integrity or proper functioning of the Raffle, as determined by MRAC in its sole discretion. In such event, MRAC reserves the right to award the prize from among remaining eligible entries received up to the time of the impairment. MRAC reserves the right, in its sole discretion to disqualify any individual, without compensation, it finds to be tampering with the entry process or the operation of the Raffle or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Raffle may be a violation of criminal and civil law, and, should such an attempt be made, MRAC reserves the right to seek damages from any such person to the fullest extent permitted by law. MRAC's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

**SELECTION AND NOTIFICATION OF WINNER:**

**Winner will be selected in a random drawing conducted online via the RallyUp platform on Saturday, November 21, 2020 at The Best of Both Worlds – The Virtual Edition party with a purpose.** Winner need not be present to win. Time of Grand Prize drawing is approximately 9:30pm. All attempts to contact the raffle ticket purchaser shall be made using the name, phone number, and email address provided. If after 21 calendar days the owner of the grand prize ticket drawn does not claim the grand prize, or in the case MRAC is unable to establish contact with said owner of the winning ticket drawn, the grand prize will be forfeited. The same will be true of any additional prize winners.

By entering, prize winners authorize the MRAC to publish their name and likeness without receiving compensation on their website, social media outlets, in local news media, and in other promotional materials used for the raffle. If winner is not present, arrangements between all parties will be made for collection of winnings within 21 days of the announcement of the winner

**TAXES AND IRS RULES:**

The raffle winner shall be responsible for all federal, state, and local income or excise taxes, fees, assessments and like charges associated with the prize. The IRS has taken the position that amounts paid for chances to participate in raffles, lotteries or similar programs are not gifts; therefore, the price of the ticket does not qualify as a deductible charitable contribution. Check with your qualified financial advisor for additional information. Information for W9 will be collected from the grand prize winner.

**WAIVER/LIMITATIONS OF LIABILITY:**

Ticket purchasers, by participating (and winner, by accepting) release MRAC executive board, committee members, company members, volunteers, partners, vendors, agents, representatives, and sponsors, and each of their respective directors, officers, partners, employees and agents, including advertising, public relations, direct marketing and promotion agencies, from any and all liability with respect to participation in the promotion and possession or use of the prize awarded and also acknowledge that they did not receive any representations, warranty or guarantee, express or implied, in fact or in law, relative to any prize. Any liability of MRAC shall be limited to ticket price

paid and in the case of any dispute, the decision shall be final. MRAC reserve the right to modify or amend these rules without notice at any time so please read this page regularly to ensure that you are updated on any changes. All decisions of MRAC are deemed final.

## DISPUTES

Except where prohibited, entrant agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Raffle or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by a state or federal court located in Cobb County, GA; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Raffle, but in no event attorney's fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant claims all rights to claim, indirect, punitive, incidental, and consequential damages and any other damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and MRAC with the Raffle, shall be governed by, and construed in accordance with, the laws of the State of Georgia, without giving effect to any choice of law or conflict of law rules (whether of the State of Georgia or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Georgia.

### **What is RallyUp?**

It is an online platform used for fundraising efforts.

### **How much are the tickets?**

Tickets are \$5 each and you can buy as many as you want!

### **How are the ticket numbers generated?**

RallyUp automatically generates unique ticket numbers for every ticket purchased. Each user is required to enter an email address to where the ticket numbers will be sent.

### **What are the prizes?**

There are 3 cash prizes - \$5,000, \$1,000 & \$500.

### **How will the winner and non-winners be notified?**

You will receive an email notification from RallyUp that will indicate who won and thanking you for your participation.

### **If I do win, when and how soon will I receive my prize?**

After completing the necessary tax form, you should receive your check no later than the 2<sup>nd</sup> Saturday in December.

### **When will the winner be announced?**

The winner will be announced ***on Saturday, November 21<sup>st</sup> at The Best of Both Worlds – The Virtual Edition*** party celebration.
